

## YUBA-SUTTER ARES NET – PROCEDURAL SCRIPT FOR NET CONTROL

**QST, QST, QST - CALLING ALL AMATEUR RADIO OPERATORS.** This is **(YOUR CALL SIGN), (YOUR NAME) in (YOUR LOCATION),** your net control station for this evening's net. Good evening and welcome to the Yuba Sutter ARES net for Thursday **MM/DD/YYYY (CURRENT DATE)**

This net meets every Thursday at 1900 hours local time on the WD6AXM repeater at 1-4-6 decimal 6-8-5 Megahertz input and 1-4-6 decimal 0-8-5 Megahertz output. The PL tone is 1-2-7 decimal 3 hertz. **DROP**

I am now placing the Yuba-Sutter ARES group on level two emergency status for the duration of the net. **DROP**

This is a directed net, formal net and all traffic is to be directed to or through the net control station. All licensed amateur radio operators are invited to check in.

In the event of an actual emergency requiring the services of the Yuba-Sutter ARES group, members should tune to this repeater, WD6AXM, and await further instructions. **DROP**

I will now pause for stations with emergency, priority, or welfare traffic.

**DROP AND RECORD STATIONS IDENTIFYING. BE PREPARED TO RELAY EMERGENCY INFORMATION AND PROVIDE DIRECTION TO THE STATIONS IDENTIFYING.**

I will now take check-ins from stations on limited time or emergency power, stations may come now. **DROP AND RECORD STATIONS IDENTIFYING**

I will now take check-ins from stations with announcements for the net, stations may come now.

**DROP AND RECORD STATIONS IDENTIFYING IN ORDER RECEIVED FOR RECALL OF ANNOUNCEMENTS FROM EACH STATION IN ORDER.**

In a moment I will take check-ins for tonight's net. Stations checking in should use ITU phonetics, and respond with your call sign, name, location, and indicate if you have comments for the net. Each station checking in should keep a list of all other stations, names, and locations that checked in on the net, so that they are prepared to take over as net control in the event that a relief net control station is needed. Stations wishing to identify to net control may come now.

## YUBA-SUTTER ARES NET – PROCEDURAL SCRIPT FOR NET CONTROL

**DROP AND RECORD STATIONS IDENTIFYING. RECORD STATIONS IDENTIFYING IN ORDER RECEIVED FOR AN ACKNOWLEDGEMENT RECALL DURING THE COMMENT ROUNDTABLE FROM EACH STATION IN ORDER.**

This is net control acknowledging check-ins from: **REPEAT EACH CALL SIGN, NAME AND QTH IN ORDER RECEIVED.**

I will now stand by for any guest check-ins. Please identify with your call sign, name and location.

**DROP AND RECORD ALL STATIONS IDENTIFYING. RECORD STATIONS IDENTIFYING IN ORDER RECEIVED FOR RECALL OF COMMENTS FROM EACH STATION IN ORDER.**

This is net control acknowledging check-ins from: **REPEAT EACH CALL SIGN, NAME AND QTH IN ORDER RECEIVED IN THIS SEGMENT.**

I will now stand by any late check-ins. Please identify with your call sign, name and location.

**DROP AND RECORD ALL STATIONS IDENTIFYING. RECORD STATIONS IDENTIFYING IN ORDER RECEIVED FOR RECALL OF COMMENTS FROM EACH STATION IN ORDER.**

This is net control acknowledging check-ins from: **REPEAT EACH CALL SIGN, NAME AND QTH IN ORDER RECEIVED IN THIS SEGMENT.**

We will now hear from those stations with comments that have checked-in to tonight's net, beginning with (CALL, NAME).

**RECALL EACH STATION IN ORDER RECEIVED AND PROVIDE EACH STATION WITH A COMMENT OPPORTUNITY UNTIL ALL STATIONS WITH COMMENTS HAVE BEEN ACKNOWLEDGED FROM THE LIST.**

That concludes the commentary portion of the net. Stations wishing to join this net, please direct your interest to **(YOUR CALL SIGN)** net control, and be prepared to provide your call sign, name and e-mail address or phone number. Your name will be placed on the roster. Stations may come now.

**DROP AND RECORD ALL STATIONS IDENTIFYING. RECORD THE INFORMATION RECEIVED FROM EACH STATION**

Thanks to all who checked into tonight's net. I invite you to return and check in each Thursday at 1900 hrs. local time on this repeater. This is **(YOUR NAME), (YOUR CALL SIGN)**, your net control station for tonight's net, returning the Yuba Sutter ARES group to its standard level one state of preparedness, and the WD6AXM repeater to normal amateur use. This net is now closed.
